

QAA Articles of Incorporation Dec 31, 2004a

Article 1. The name of the corporation is Quiet Aircraft Association, Inc. Hereinafter referred to as QAA.

Article 11. This corporation is organized exclusively for charitable, literary, historical, scientific, and educational purposes, including such purposes as the making of contributions to organizations that under section 501 c (3) of the Internal Revenue Code, or any corresponding section of any future federal tax code.

No proceeds of the corporation shall enrich any individual in the corporation.

If the corporation is dissolved, any assets remaining shall be distributed to another corporation serving a similar purpose and qualify as a tax-exempt charitable organization under provisions of section 501 c (3) of the Internal Revenue Code.

Article 111. This corporation shall exist in perpetuity unless dissolved.

Article 1V. This corporation is organized to:

1. Gather, record, assemble, and preserve the history, art, and artifacts of the Quiet Aircraft. The Quiet Aircraft are defined as the Quiet Thruster (QT) QT-1, QT-2, Q-Star, X-26, and YO-3A Aircraft including their various configurations: QT-2PC, QT-2PCII, and U.S. ARMY, Louisiana Department of Wildlife and Fisheries (LDWF), Federal Bureau of Investigation (FBI), and National Aeronautics and Space Administration (NASA) YO-3As.
2. Share any/all of the above items (originals or copies) with members and public institutions (i.e. museums and other historical or educational) for access by researchers and historians in perpetuity. Items shall include, but not be limited to visual, voice, digital, and physical media.
3. Educate the public, writers, historians, and researchers involved in developing future quiet aircraft. Activities shall include, but not be limited to operating world-wide-websites, personal appearances, publishing visual, aural, and digital media, and providing artifacts.
4. Recognize the contributions of the aircraft sponsors, developers, and operators and preserve their memories.
5. Support museums and other organizations, and other persons possessing Quiet Aircraft, and associated art, artifacts, and information.

Article V. Members: The corporation shall have members. The members of this corporation shall be defined in our bylaws.

Article V1. The management of the corporation shall be vested in its officers and members as defined in its bylaws. Officers shall be elected at the first general meeting, or as soon as possible thereafter. Bylaws shall be established at the first general meeting, or as soon as possible thereafter.

Article V11. Bylaws: The operation and provisions of the corporation shall be defined by its bylaws.

Article V111. Initial Agent and address: Mr. Dale Ross Stith shall be the corporation's initial agent.

Article 1X. The initial Officers of the Corporation shall be as indicated in this article. They shall serve as unpaid volunteers until the next general meeting, at which time an election, open to all members of the organization, shall be held. The officers shall serve as described by our bylaws. Initial Officers:

President: Mr. Dale Ross Stith as shown in Article V111.

Vice President and Treasurer: Mr. Kurt Olney (Note: Kurt Olney has vacated this position and George Walker has volunteered to perform this task until upcoming QAA Elections are completed. Kurt will continue as QAA Webmaster).

Vice President and Secretary: Mr. Sidney Morrow.

Article X. Incorporator: The creator of this corporation is Mr. Dale Ross Stith as shown in Article V111, whose address is also as shown in Article V111.

Article XI. Distribution of Assets on Dissolution. The assets of the corporation shall be distributed in a manner provided by Article 6.02(3) of this Act.
